The Board of Directors of the Harris County Appraisal District will hold a public hearing on a proposed budget for the 2019 fiscal year.

The public hearing will be held on Wednesday, July 18, 2018 at 9:30 o'clock a.m., in the Board of Directors Room in the central offices of the Harris County Appraisal District, 13013 Northwest Freeway, Houston, Texas. At such public hearing any and all persons desiring to be heard on any matter relating to the proposed budget will be afforded the opportunity to be heard.

A summary of the appraisal district budget follows:

The total amount of the proposed budget is \$88,094,531.

The total amount of increase over the current year's budget is \$2,532,444 or 2.96%

The number compensated under the proposed budget will be 661 employees and 190 appraisal review board members. The number compensated under the current budget is 661 employees and 190 appraisal review board members.
