## PROPERTY APPRAISAL NOTICE OF PROTEST

## REQUEST FOR SAME-DAY PROTEST HEARING

**INSTRUCTIONS:** This form is for use by a property owner or designated agent that wishes to have the ARB schedule hearings on protests concerning up to 20 designated properties on the same day pursuant to Tax Code §41.66(j). All designated properties for which same-day protest hearings are requested must be included in the same notice of protest. A property owner or designated agent may file only one request for same-day protest hearings in the same tax year.

**A property owner or agent protesting a single property or not requesting same-day protest hearings may use HCAD's Form 41.44 Notice of Protest (visit [www.hcad.org/forms](http://www.hcad.org/forms)) or Comptroller's Form 50-132 (Property Appraisal – Notice of Protest) to file a protest with the ARB.**
