Application for Exemption of Goods-In-Transit Tax Year _____

GENERAL INSTRUCTIONS: This exemption application applies to "goods-in-transit" as governed by Tax Code §11.253. "Goods-in-transit" means tangible personal property that: (1) is acquired in or imported into this state to be forwarded to another location in this state or outside this state; (2) is stored under a contract of bailment by a public warehouse operator at one or more public warehouse facilities in this state that are not in any way owned or controlled by the owner of the personal property for the account of the person who acquired or imported the property; (3) is transported to another location in this state or outside this state not later than 175 days after the date the person acquired the property in or imported the property into this state; and (4) does not include oil, natural gas, petroleum products, aircraft, dealer's motor vehicle inventory, dealer's vessel and outboard motor inventory, dealer's heavy equipment inventory, or retail manufactured housing inventory. For the purposes of this application, "inventory" means your inventory of finished goods, raw materials and work in process.

APPLICATION DEADLINES: You must file the completed application with all required documentation between January 1 and no later than April 30 of the year for which you are requesting an exemption. You must furnish all information and documentation required by the application.

ANNUAL APPLICATION REQUIRED: You must apply for this exemption each year you claim entitlement to the exemption.

OTHER IMPORTANT INFORMATION: Pursuant to Tax Code §11.45, after considering this application and all relevant information, the chief appraiser may request additional information from you. You must provide the additional information within 30 days of the request or the application is denied. For good cause shown, the chief appraiser may extend the deadline for furnishing the additional information by written order for a single period not to exceed 15 days.
