If the chief appraiser grants the exemption, the exemption for that year applies only to the portion of the year in which the property qualified for the exemption. If you have filled out this form online, you must print it, sign it and mail it to the address above.

#### OTHER IMPORTANT INFORMATION

Pursuant to Tax Code Section 11.45, after considering this application and all relevant information, the chief appraiser may request additional information from you. You must provide the additional information within 30 days of the request or the application is denied. For good cause shown, the chief appraiser may extend the deadline for furnishing the additional information by written order for a single period not to exceed 15 days.
